

GHS 2010 After Prom Party and Prom Bus Permission Slip

The Glenelg High School (GHS) Administration, with support from the GHS PTSA, will be hosting our 5th Annual After Prom Party on May 16, 2010, from 12:00am-3:30am at the ESPN Zone, located in Baltimore Maryland. As a service to our community, the option of taking a bus from the ESPN Zone to Glenelg High School during and after the party will be offered. One bus will leave the ESPN Zone at approximately 2:30am; the remaining buses will depart for Glenelg High School at approximately 3:30am. Parents are responsible for providing transportation from the school to your homes once buses return to GHS after the After Prom Party.

Tickets must be purchased prior to the event HCPSS policy prohibits ticket sales at the door

*You do not have to attend prom to attend the after prom, but you must provide your own transportation to the after prom
In order to ensure we have enough buses, you must select your transportation option when purchasing your tickets.*

The following rules have been implemented for the safety of all those in attendance and must be followed without exception:

1. **All** participants must have a permission slip signed by the student and their parents/guardians.
2. No Alcohol, Drugs or Smoking will be permitted.
3. All students/guests must exhibit appropriate behavior at all times and follow Howard County Public School System, (HCPSS) policies.
4. All students/guests IDs will be checked at the door. Please bring school ID or Driver's License.
5. **Participants are expected to arrive by the 1:00 AM, door-closing time. No one will be admitted after that time.**
6. Students/guests will not be allowed to reenter the party once they have left.
